3.	Basic Pay fixed as on 01.01.2019 i.e. the date of promotion to Selection Grade [Level 13 of 7 <sup>th</sup> CPC] after allowing two Additional Increments in Level 13 under Rule 5(6) ibid	Rs.1,75,500/-
4.	Pay re-fixed on 01.07.2019 after allowing Increment in terms of Rule 8 ibid.	Rs.1,80,800/-

Arrear due to the aforesaid pay fixation in the revised scale as per IAS (Pay) Rules, 2016 will be drawn separately.


Next increment of the concerned officers, after issue of this order, in terms of the rules ibid, if otherwise admissible, will fall due on 01.07.2020.
