ORDER

Md. Salman Husaini, WBCS (Exe.), now posted as Dy. PD (WD), DRDC, Malda, was appointed on promotion from the feeder post of Jt. BDO to the WBCS(Exe) Cadre, in the Pay Band (PB-4A) of Rs.15600-42000/- with Grade Pay of Rs.5400/- under Notification No.333-PAR(WBCS) dated 27.01.2009 and he joined the said post on **06.02.2009 (FN)**. Md. Husaini was **confirmed** in the said cadre **w.e.f. 21.11.2013** in terms of this Department Notification No. 132-PAR (WBCS)/8P-39/15 dated 01-02-2016.

Recently, Md. Husaini has been awarded 8 years MCAS benefit vide this department Order No.510-PAR (WBCS)/1D-138/2017 dated 03.04.2019 **w.e.f. 06.02.2017** and he is thus entitled to get the movement of 1st higher scale of pay in PB-4A of Rs.15600-42000/- plus Grade Pay of Rs.6600/- from PB-4A of Rs.15600-42000/- Plus Grade Pay of Rs.5400/-.

Md. Husaini has exercised his option to fix his pay w.e.f. 01.07.2017 for the said benefit.

Earlier, the pay of Md. Husaini was fixed @ Rs. 23,640/- (BP- Rs. 18,240/- + Gr. Pay Rs. 5,400/-) w.e.f. 01.07.2009 in the pay band PB-4A of Rs. 15600-42000/- with Grade Pay of Rs.5400/- under ROPA'2009 vide order no. 846 /Estt. Dated 30.06.2009 from O/o the District Magistrate & Collector, Howrah.

Now, as per option the pay of Md. Husaini is hereby fixed in the following manner:-


Next increment will fall due on 01.07.2019, if otherwise eligible. Then the pay of Md. Husaini will be fixed @Rs.36,140/- w.e.f. 01.07.19 in the PB-4A with Grade Pay of Rs.6600/-.

Md. Husaini will due to retire on superannuation on 31.12.2019. The last pay of Md. Husaini will be fixed @Rs.36,140/- on that day.

Md. Husaini is eligible to get arrear in pay and allowances arising out of his fixation of pay in the above manner.

Overdrawal of pay and allowances, if any, due to aforesaid fixation of his pay, will be recovered.
