NOTIFICATION

**Smt. Asita Misra**, WBCS (Exe.), joined in the WBCS (Exe.) cadre on 14/09/1993 (F.N.) is senior to **Smt. Meghna Bhattacharya**, WBCS (Exe.), who joined in the same cadre on 15/09/1993 (F.N.) as per the WBCS cadre gradation list as on 01/01/2013.

2. **Smt. Meghna Bhattacharya** was awarded the benefit of two additional increments, notionally, w.e.f. 01/07/14 and actually, w.e.f. 01/10/14 in terms of the Notification No.1939-PAR(WBCS)/1D-164/12 Pt-I dated 19/11/14 and her pay had been fixed at **Rs.43810/-** (Rs 36210/- + Rs 7600/-) in **PB 4B** of Rs. 28000/-52000/- with Gr. Pay of Rs.7600/- under WBS(ROPA) Rules, 2009, and subsequently, in pursuance of P & AR Department's Notification No.1957-PAR(WBCS)/1D-86/2010 Pt. Dated 21/11/14, **Smt. Bhattacharya** was appointed to the unrevised scale No.19 under the WBS(ROPA) Rules,1998 corresponding to the revised **PB 5 of Rs.37400/-60000/-** with Grade Pay 8700/- and her Pay was fixed at **Rs.46230/-**(Rs.37530/- + Gr.Pay Rs.8700/-) with a special allowance of Rs.1000/- p.m. w.e.f 01/11/14.

3. At that point of time Pay of **Smt. Misra** stood at Rs.46100/-( BP Rs.37400/- + Gr.Pay Rs. 8700/-) with special allowance of Rs.1000/- p.m. Pursuant to the Finance Department's memo No. 3015-F dated 13/03/2001 read with P&AR Department's memo No. 1198-PAR(WBCS) dated 26/03/01 he had been appointed to the unrevised scale No.19 corresponding to revised **PB 5 of Rs.37400/-60000/- with Grade Pay Rs.8700/-** with a special allowance of Rs.1000/- p.m. w.e.f.25/04/14(A.N) and her pay had been fixed at Rs.46100/- (BP Rs.37400/- + Grade Pay Rs.8700/-) in the said PB 5.

4. The undersigned is, therefore, directed by order of the Governor to say that, after careful consideration of the anomaly in pay in the instant case, the Governor has been pleased to accord sanction to the stepping up of the pay of the senior Officer **Smt. Asita Misra**, WBCS (Exe.) to **Rs. 46230/-** ( Rs.37530/- + Gr.Pay Rs.8700/-) with a special allowance of Rs.1000/- p.m. w.e.f **01/11/14**, in terms of rule 55(4) of WBSR pt-I to make it at par with that of her junior counterpart **Smt. Meghna Bhattacharya**.

5. The Governor is further pleased to allow normal annual increment to **Smt. Misra** raising her pay to **Rs.47620/-**(Rs 38920/- + Rs 8700/-) w.e.f. 01/07/2015, **Rs.49050/-**(Rs.40350/- + Rs.8700/-) w.e.f. 01.07.2016 in the same **PB 5 of Rs.37400/-60000/-** with Grade Pay 8700/- under **WBS (ROPA), 2009**.

6. This order issues with the concurrence of Finance Department vide their **U.O.No.GroupP1/2017-2018/0236 dated 21/09/2017**.

8. The Principal Accountant General (A&E), West Bengal, is being informed accordingly.

9. This order cancels the previous G.O.No.-1310 - PAR (WBCS)/1D-195/17 Dated-25.09.2017.


