Consequent upon creation of the post of Additional Secretary in Pay Level - 22 for the WBCS (Exe) officers necessary provision for fixation of pay is felt necessary in HRMS with clarification as to whether interim pay fixation benefit is admissible in case a WBCS(Exe) officer, after movement to revised Level-21, 22 and 24 opts to get the pay fixation benefit with effect from the date of next increment.

After careful consideration of the matter, the Governor is pleased to order that movement of WBCS(Exe) officers to revised Level-21, 22 and 24 shall be treated as non-functional movement and no interim pay fixation benefit is admissible in case an officer opts to get the pay fixation benefit with effect from the date of next increment.

This issues with the concurrence of the Finance Department issued vide their U.O. No. Gr.P1/2021-2022/0170 dated 23.08.2021.

This Notification will come into force from the date of issue of Notification No.180-PAR(WBCS) dated 08.02.2021.
