# NOTIFICATION

# No. 1346-PAR(WBCS)/1D-153/21

#### Dated, the 16th September, 2021

In pursuance of the Cabinet decision dated 8<sup>th</sup> February, 2021 for restructuring of the WBCS(Executive) Cadre, forty (40) additional posts in the Super Time Scale corresponding to Level 24, under the WBS (ROPA) Rules, 2019, were created vide No. 183-PAR(WBCS) of this Department dated 08.02.2021.

Thirty-Six (36) WBCS (Exe) officers in Level 22, mentioned in 'Schedule' below, are otherwise eligible to move to the newly created posts in Level 24, but their service period in Level 22 falls short of the mandatory minimum service period of 2 years as per 2nd Proviso to Rule 4(2) of West Bengal Civil Service (Executive) Officers' Pay Rules, 2021

The said officers have already served in Level 21 (as Joint Secretary) for a considerable period, ranging from about 7 years to more than 8 years, which is much more than the mandatory service period of four (4) years required for movement from Level 21 to Level 24 (through Level 22). Moreover, they would easily have moved from Level 21 to Level 24 with the creation of the new posts in Level 24 but for the introduction of the new Level 22 in the WBCS (Exe) Officers' Pay Rules, 2021, on 08.02.2021

Thus, making them serve for another 2 years at Level 22 would not only defeat the very purpose of creation of those posts at Level 24 by keeping them vacant for a considerable period, but also cause unnecessary hardship to those officers.

Thus, in view of what has been stated above, the Governor, considering it expedient to do so in the interest of public service, and in exercise of the power of relaxation conferred by the second proviso to Rule 4(2) of the West Bengal Civil Service (Executive) Officers' Pay Rules, 2021, is pleased to partially relax the mandatory criteria of the minimum period of two years of satisfactory service at level 22 in respect of the 36 (Thirty-six) W.B.C.S (Exe.) Officers shown in 'Schedule' below and to appoint them in the Super Time Scale corresponding to Level 24 of the WBS(ROPA) Rules, 2019, i.e. Rs.1,28,900/- - Rs.2,01,000/- and other admissible allowances with effect from 01/09/2021.

The pay of the Officers mentioned in the aforementioned 'Schedule' will be fixed according to Rule 4(3)(b) of the West Bengal Civil Service (Executive) Officers' Pay Rules, 2021 read with WBS(ROPA) Rules, 2019.

Further, with effect from the date mentioned above, the designation of the Officer posted in the Secretariat Department will be Special Secretary to the Government and in case she/he is

posted outside the Secretariat will have the rank, status and responsibility of a Special Secretary and the designation of the officer posted outside the Secretariat and having designation as exofficio Addl. Secretary will be re-designated as ex-officio Special Secretary.

Moreover, the post held by the Officer in the Secretariat Department will be deemed to have been upgraded to Special Secretary and the post held by the Officer outside the Secretariat as equivalent to Special Secretary with effect from the date mentioned above, so long as the post is held by the Officer. The rank and status of the post will be reverted to its original status when vacated by the Officer, unless otherwise directed. The post which the aforesaid Officer has been so long holding will not be filled up till the post upgraded hereinabove in the concerned Department is vacated by her/ him.

The charge will proceed against the appropriate head of account of the State Government.
