**ORDER**

Final pay, fixed on 18.03.2020 after allowing two additional increments in Level-12 after placing the pay arrived as stated above in the appropriate cell i.e., initial stage of Level 12	Rs.83,600/- [Rs.78,800→ Rs.81,200→ Rs.83,600]
Basic Pay on 01/01/2021 after allowing increment, if otherwise admissible	Rs.86,100/-

4. Arrear due to the aforesaid pay fixation in the revised scales as per IAS (Pay) Rules, 2016 is to be drawn separately.

5. The Officer would continue to draw Administrative Allowance/Special Allowance as per extant rules.

6. Overdrawal, if any, arising out of this fixation would be recovered from Pay & Allowances of the officer concerned, in due course.
