The Governor has further been pleased to state that with effect from the date mentioned above, the designation of the Officer posted in the Secretariat Department will be Joint Secretary to the Government and in case he is posted outside the Secretariat will have the rank, status and responsibility of a Joint Secretary with effect from the date. The post held by the Officer in the Secretariat Department will be deemed to have been upgraded to Joint Secretary and the post held by the Officer outside the Secretariat as equivalent to Joint Secretary with effect from the date mentioned above, so long as the post is held by the Officer. The rank and status of the post will be reverted to its original status when vacated by the Officer, unless otherwise directed.

The post, which the aforesaid Officer has been so long holding, will not be filled up till the post upgraded hereinabove in the concerned Department is vacated by him.

The charge will proceed against the appropriate head of account of the State Government.
