All the officers will be on probation for a period of 2 (two) years with effect from the date of their joining in the service. Their confirmation will depend on their satisfactory services and on passing the Half-yearly Departmental Examination, prescribed for the promotee officers, in terms of the relevant provisions in the W.B.C.S.(Training and Examination) Rules. In the event, if they are considered to be unsuitable for the service, they will be liable to reversion to their respective feeder posts during the end of the period of their probation.

The Department of P & RD is requested to make arrangements for release of the concerned officers, appointed as Deputy Magistrate and Deputy Collector (on probation), hereinabove, in order to enable them to join as Deputy Magistrate and Deputy Collector (on probation) at BRAIPARD, Kalyani, Nadia on 17-03-2025 at 10 a.m.
