The rank and status of the posts will be reverted to their original status when vacated by the Officers, unless otherwise directed. The posts which the aforesaid Officers have been so long holding will not be filled up till the posts upgraded hereinabove in the concerned Departments are vacated by them.

The charge will proceed against the appropriate head of account of the State Government.
