ORDER

Shri Dipankar Chowdhury, WBCS(Exe), has been appointed to the unrevised scale no. 21 under ROPA-1998, Rs. 18,400-500-22,400/- corresponding to revised Pay Band Scale PB-5 of Rs.37,400-60,000/- plus Grade Pay of Rs.10,000/- with a special allowance of Rs.1,000/-p.m. w.e.f. 04.02.2016 i.t.of this Deptt.'s Notification No.620-PAR(WBCS)/1D-269/15 dated 05.06.2017 under WBS (ROPA) Rules, 2009.

2. Shri Chowdhury has exercised his option to fix his pay w.e.f. 04.02.2016 and re-fix w.e.f. 01.07.2016 in PB-5 of Rs.37,400-60,000/- plus Grade Pay of Rs.10,000/- under Note 1 below of Rule 11 of WBS (ROPA) Rules, 2009.

3. Prior to such appointment, Shri Chowdhury was drawing pay @ Rs.41,690/- plus Grade Pay Rs.8,700/- amounting to Rs.50,390/- w.e.f. 01.07.2015 in the Pay Band PB-5 of Rs.37,400-60,000/- with Grade Pay Rs.8,700/- under WBS (ROPA) Rules, 2009.

4. Now, as per his option the pay of Shri Chowdhury, is hereby fixed at Rs.41,690/- plus Grade Pay Rs.10,000/- amounting to Rs.51,690/- w.e.f. 04.02.2016 in the Pay Band-5 of Rs.37,400-60,000/- plus Grade Pay Rs.10,000/- with a special allowance of Rs.1,000/-p.m. and re-fixed at Rs.44,770/- plus Grade Pay Rs.10,000/- amounting to Rs.54,770/- w.e.f. 01.07.2016 in the same Pay Band-5 of Rs.37,400-60,000/- with Grade Pay Rs.10,000/- in terms Rule 11, below note -1 of WBS(ROPA) Rules 2009, read with P.& A.R Deptt. Memo No-1804-PAR(WBCS) Dt.25.06.2010.

5. In terms of this deptt. notification no. 39-PAR (WBCS) dated 16.01.2017, by allowing 2(two) additional increments, the pay of Shri Chowdhury is hereby further fixed at Rs.58,120/- (BP-Rs.48,120/- + Grade Pay Rs.10,000/-) notionally from 01.07.2016 and actually w.e.f. 01.12.2016 in the same Pay Band-5 of Rs.37,400-60,000/- with Grade Pay Rs.10,000/- with a spl. allowance of Rs.1000/- p.m..

6. Now, by allowing normal periodical increment on 01.07.2017 the pay of Shri Chowdhury will be fixed at Rs. 59,870/-(BP- Rs.49,870/- + Grade Pay Rs. 10,000/-) with a spl. Allowance of Rs.1000/- p.m. in the same Pay Band under ROPA'09, if otherwise eligible.

7. This order supersedes the previous fixation order vide no. 248-PAR (WBCS)/1D-10/17 dated 27.02.2017 allowing benefit of 2(two) additional increments i.t.of notification no. 39-PAR (WBCS) dated 16.01.2017 in the lower scale of pay of Rs.37,400-60,000/- with Grade Pay Rs.8,700/- in PB-5 under WBS (ROPA) Rules, 2009.

8. The Principal Accountant General (A & E), West Bengal is being informed accordingly.
