Whereas. In pursuance of order issued by P&AR Deptt.(WBCS Cell) vide Notification No. 957-PAR(WBCS)/1D-193/2016 Dated. 15/07/2016 read with Finance Deptt. memo. No. 3015-F dated 13/3/2001, P& AR Deptt. Memo No. 1198-PAR(WBCS) dated 26/03/2001 & No. 4020-PAR(WBCS) dated 07/10/2004, Shri Chanchal Majumdar, WBCS(Exe), Dy. Magistrate & Dy. Collector, Barasat, North 24-Parganas has been allowed 8 years MCAS benefit w.e.f. 08 /04/2016. He is allowed to draw scale no. 17 of WBS (ROPA) Rules,1998 corresponding to the revised Pay Band PB-4A of **Rs. 15,600-42,000/- with grade pay of Rs. 6600/-** of W.B.S.(ROPA) Rules, 2009.
