ORDER

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord administrative approval for implementation of the Scheme "Up-gradation of Electrical Installation at P & A.R. Department, Writers' Buildings – EI work at Block-IV, 2nd Floor" at an estimated cost of Rs. 5, 38, 774/- (Rupees five lakh thirty eight thousand seven hundred and seventy four) only.

The Governor has further been pleased to accord sanction to the release of fund amounting to Rs. 5, 38, 774/- (Rupees five lakh thirty eight thousand seven hundred and seventy four) only for the work mentioned in Para 1 above and to the allotment of an equivalent amount at the disposal of the Chief Engineer (Electrical)-I, P.W.D., for the execution of the work by the Executive Engineer (Electrical), PWD, Calcutta Electrical Division, subject to (i) strict observance of all relevant financial rules & regulations of this Government (ii) timely completion of the work to avoid escalation of cost (iii) non-deviation of allotted fund from the approved Scheme and (iv) submission of Utilization Certificate of the fund allotted hereinabove within six months from the date of drawal of the same & Physical Progress Report of the Scheme mentioned in Para 1 above.

The charge involved is debitible to the Head of Account "4059-Capital Outlay on Public Works-01-Office Buildings-051-Construction-SP-State Plan (Annual Plan & XI/XII th Plan)-015-Other Administrative Services [HR]-V-53-Major works/Land and Buildings" under Demand No.42 in the budget for the financial year 2012-2013.

4. The Executive Engineer (Electrical), PWD, Calcutta Electrical Division, will act as Drawing & Disbursing Officer in respect of the fund sanctioned hereinabove.

5. This order is issued with the approval of the Secretary of this Department and in exercise of powers delegated under Finance Department's Memo No. 95-F.B. dated 18.04.2012 and No. 1700-F.B. dated 31.12.2012.
