ORDER

The undersigned is directed by order of the Governor to say that the Governor had been pleased to accord administrative approval for implementation of the Scheme "Construction of 4th storey over existing 3rd floor of New Administrative Building at Barasat, North 24-Parganas" at an estimated cost of Rs. 2, 88, 99,860/- (Rupees two crore eighty eight lakh ninety nine thousand eight hundred and sixty) only with an allotment of fund amounting to Rs. 1, 00, 00,000/- (Rupees one crore) only vide this Department's G.O. No. 140 (Sanction)-PAR (AR)/P/1B-63/2010 dated 16.12.2010.

2. Further allotment of fund to the tune of Rs. 1, 00, 00,000/- (Rupees one crore) only had been made only vide this Department's G.O. No. 207 (Sanction)-PAR (AR)/P/1B-63/2010 dated 21.03.2012.

3. Now on obtaining the Utilization Certificate for Rs. 1, 71, 14,857/- (Rupees one crore seventy one lakh fourteen thousand eight hundred and fifty seven) only out of the total allotted fund of Rs. 2, 00, 00,000/- (Rupees two crore) only, the Governor has been pleased to accord sanction to the further release of fund amounting to Rs. 88, 99,860/- (Rupees eighty eight lakh ninety nine thousand eight hundred and sixty) only for the work mentioned in Para 1 above and to the allotment of an equivalent amount at the disposal of the District Magistrate, North 24-Parganas for the execution of the work by the Executive Engineer, P.W.D., Barasat Division subject to (i) strict observance of all relevant financial rules & regulations of this Government (ii) timely completion of the work to avoid escalation of cost (iii) non-deviation of allotted fund from the approved Scheme and (iv) submission of Utilization Certificate of the fund allotted hereinabove within six months from the date of drawal of the same & Physical Progress Report of the Scheme mentioned in Para 1 above.

4. The entire amount equivalent to the total estimated cost of Rs. 2, 88, 99,860/- (Rupees two crore eighty eight lakh ninety nine thousand eight hundred and sixty) only has thus been released including the present sanction.

5. The charge involved is debitable to the Head of Account "4059-Capital Outlay on Public Works-01-Office Buildings-051-Construction-SP-State Plan (Annual Plan & XII th Plan)-015-Other Administrative Services [HR]-V-53-Major works/Land and Buildings" under Demand No.42 in the budget for the financial year 2013-2014.

6. The District Magistrate, North 24-Parganas will act as Drawing & Disbursing Officer in respect of the fund sanctioned hereinabove.

7. This order is issued with the approval of the Secretary of this Department and in exercise of the power delegated under Finance Department's Memo No. 622-F.B. dated 01.08.2013.
