**ORDER**

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord administrative approval for implementation of the Scheme "Augmentation in the infrastructure of E.V.M. Warehouse at Arambagh Sub-Division in the district of Hooghly" at an estimated cost of Rs. 1, 52, 573/- (Rupees one lakh fifty two thousand five hundred and seventy three) only.

The Governor has further been pleased to accord sanction to the release of fund amounting to Rs. 1, 52, 573/- (Rupees one lakh fifty two thousand five hundred and seventy three) only for the work mentioned in Para 1 above and to the allotment of an equivalent amount at the disposal of the District Magistrate, Hooghly for execution of the work by the Assistant Engineer, MGNREGS, Arambagh Sub-Division subject to (i) strict observance of all relevant financial rules & regulations of this Government, (ii) timely completion of the work to avoid escalation of cost, (iii) non-deviation of allotted fund from the approved Scheme and (iv) submission of Utilization Certificate of the fund allotted hereinabove within six months from the date of drawal of the same & Physical Progress Report of the Scheme mentioned in Para 1 above.

3. The charge involved is debitable to the Head of Account "4059-Capital Outlay on Public Works-01-Office Buildings-051-Construction-SP-State Plan (Annual Plan & XII th Plan)-015-Other Administrative Services [HR]-V-53-Major works/Land and Buildings" under Demand No.42 in the budget for the financial year 2013-2014.

4. The District Magistrate, Hooghly will act as Drawing & Disbursing Officer in respect of the fund sanctioned hereinabove.

5. This order issues with the approval of the Secretary of this Department and in exercise of the power delegated under Finance Department's Memo No. 95-F.B. dated 18.04.2012 and No. 622-F.B. dated 01.08.2013.

6. All concerned are being informed accordingly.


