2. The above mentioned IAS Officers have opted to get their pay fixed with effect from the date of their promotion i.e. 01.01.2023 under rule 5(9) of the IAS (Pay) Rules, 2016.

3. Prior to their promotion, the pay of the above mentioned IAS Officers stood at Rs. 61,300/- allowing advance increment on 01.07.2021 which is retained upto 31.12.2022 without any further increment at Level 10 of the Pay Matrix in the IAS (Pay) Rules, 2016.

4. Consequent upon their promotion to the Senior Time Scale of IAS (Level 11 of the 7<sup>th</sup> CPC), the Governor is pleased to fix the pay of the above mentioned IAS Officers under rule 5(2) of the IAS (Pay) Rules, 2016, with effect from 01.01.2023 as detailed below :

ii)	Basic Pay as fixed on 01.01.2023 i.e. the date of promotion to Senior Time Scale of IAS (Level 11 of the 7 <sup>th</sup> CPC) after placement in appropriate cell at level 11 allowing one increment at Level 10 and subsequent two additional increments at Level 11	<b>Rs. 71,800/-</b> Rs. 67,700/- (Initial stage of Level-11) → Rs.69,700/- → Rs.71,800/-

5. In terms of Rule 8(c) of IAS(Pay) Rules, 2016 pay of the Officers, mentioned above, are to be re-fixed with effect from 01.07.2023 raising their pay from Rs. 71,800/- to Rs. 74,000/-.

6. Arrear due to the aforesaid pay fixation in the revised scales as per IAS (Pay) Rules, 2016 are to be drawn separately.
7. Overdrawal arising out of the above pay fixation, if there be any, will be recovered from the pay and allowances of the Officers concerned in due course.
8. The Officers concerned are entitled to draw Special Allowances, as admissible.
9. Next increment of the Officers concerned in terms of the rules ibid, if otherwise admissible, will fall due on 01.07.2024.
