The Governor has further been pleased to state that with effect from the date mentioned above, the officers will be re-designated as Additional Secretary to the Government while posted in the Secretariat Department or as Ex-Officio Additional Secretary while posted out-side the State Secretariat. The post held by the officer in the Secretariat Department will be deemed to have been upgraded to Additional Secretary and the post held by the officer outside the Secretariat as equivalent to Additional Secretary with effect from the date mentioned above, so long as the post is held by the Officer. The rank and status of the post will be reverted to its original status when vacated by the Officer, unless otherwise directed.

The post, which the aforesaid Officer has been so long holding, will not be filled up till the post upgraded hereinabove in the concerned Department is vacated by her/ him.

The charge will proceed against the appropriate head of account of the State Government.


