Of late, Indian Administrative Service (Pay) Rules 2016 has been amended under Notification No.GSR 914(E) dt.30.12.2021 and Note 4 has been inserted after Note 3 below Rule 3(1) of said Rules wherein it has been mentioned that a member of the service shall file Immovable Property Return (IPR) for the previous year within the time frame specified for the purpose, i.e. 31th January for being considered for appointment in the next level of pay in the pay matrix.

DoPT, Govt. of India vide their No. 11030/06/2021-AIS-II dt. 28.06.2022 has now informed that as a one-time measure, the window for filing of the missing IPRs of the IAS Officers, if any from 01.01.2011 onwards will remain open w.e.f. 15.07.2022 to 14.09.2022 to enable the IAS Officers to file their missing IPRs, if any w.e.f. 01.01.2011 onwards.

Accordingly, copies of the Notification No.GSR 914(E) dt.30.12.2021 and 11030/06/2021-AIS-II dt. 28.06.2022 of DoPT, are now sent to you for circulation of the same among the respective service officers under the administrative control of your department

Subject: Instructions for filing of Immovable Property Return (IPR), subject to Note 4 of IAS (Pay) Rules, 2016 -reg.

Sir / Madam,

I am directed to refer to the amendments carried out in the IAS (Pay) Rules, 2016 vide Notification dated 30<sup>th</sup> December, 2021 whereby Note 4 has been inserted in Rule 3 (1) of the said pay rules to make filing of IPR mandatory for being considered for appointment to the next level of pay matrix. The proviso below said Note 4 inserted in IAS (Pay) Rules, 2016 reads as under:

"Provided that a member of service, who has not filed the IPR for any of the year prior to coming into force of the Indian Administrative Service (Pay), Amendment, Rules, 2021, shall file the same within such period, as may be laid down by the Central Government in this behalf, for being considered for appointment in the next level of pay in the pay matrix.".

- 2. As mandated by the proviso to the above said Note 4 of IAS (Pay) Rules, 2016, the Central Government hereby clarifies that the missing IPRs of IAS officers, if any, from 01.01.2011 onwards, are to be filed during such timelines as would be prescribed by the Gol through separate instructions.
- The above clarifications are being issued for the limited purpose of amended provisions of IAS (Pay) Rules only and will not, in any way, affect the overall provisions regarding filing of IPR as contained in the AIS (Conduct) Rules, 1968.
- This issues with the approval of the Competent Authority.

  - (2) ये राजपत्र में उनके प्रकाशन की तारीख को प्रवृत्त होंगे।
- 2. भारतीय प्रशासनिक सेवा (वेतन) नियम, 2016 के नियम 3 के उपनियम (1) में, टिप्पण 3 के पश्चात् और स्पष्टीकरण 1 से पहले, निम्नलिखित टिप्पण अंत:स्थापित किया जाएगा, अर्थात् :--

"टिप्पण 4—सेवा का सदस्य, बेतन मैट्रिक्स में बेतन के अगले स्तर में नियुक्ति के लिए बिचार किए जाने हेतु, पिछले वर्ष के लिए अचल संपत्ति विवरणी (आईपीआर), इस प्रयोजन के लिए बिनिर्दिष्ट समयसीमा के भीतर, अर्थात 31 जनवरी तक, फाइल करेगा:

परंतु सेवा का सदस्य, जिसने भारतीय प्रशासनिक सेवा (वेतन) संशोधन नियम, 2021 के प्रवृत्त होने से पूर्व किसी वर्ष का आईपीआर फाइल नहीं की है, वेतन मैट्रिक्स में वेतन के अगले स्तर में नियुक्ति के लिए विचार करने के लिए, जैसा कि इस निमित्त केंद्रीय सरकार द्वारा अधिकथित किया जा सके, ऐसी अवधि के भीतर उसे फाइल करेगा।"।

### NOTIFICATION

G.S.R. 914(E).—In exercise of the powers conferred by sub-section (1) of section 3 of the All India Services Act, 1951 (61 of 1951), the Central Government, after consultation with the Governments of States concerned, hereby makes the following rules further to amend the Indian Administrative Service (Pay) Rules, 2016, namely:—

- 1. (1) These rules may be called the Indian Administrative Service (Pay), Amendment, Rules, 2021.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Indian Administrative Service (Pay) Rules, 2016, in rule 3, in sub-rule (1), after Note 3 and before the Explanation 1, the following Note shall be inserted, namely:-

"Note 4.- A member of the service shall file Immovable Property Return (IPR) for the previous year within the time frame specified for the purpose, i.e. 31st January, for being considered for appointment in the next level of pay in the pay matrix:

Provided that a member of service, who has not filed the IPR for any of the year prior to coming into force of the Indian Administrative Service (Pay), Amendment, Rules, 2021, shall file the same within such period, as may be laid down by the Central Government in this behalf, for being considered for appointment in the next level of pay in the pay matrix."
